The Changing of the Guard



progress for the club. We thank Carver Wood for his steady hand throughout 2001. It was a busy year and a most successful one. Good things happened and





Executive Board Actions

At the executive board meeting on January 8, 2002, several decisions were approved concerning Friday meetings. These decisions are directed at assuring compliance with The Community House capacity limitations while maximizing seat availability for members staying for lunch.


First, regular members and applicants will be strongly encouraged to satisfy their minimum meeting requirements by the end of September each year. This should minimize the fourth quarter crowding that has strained The Community House capacity.

Second, members and applicants staying for lunch are requested to place their lunch ticket at a selected table place setting at least five minutes before 10:30 AM. Sergeant-at-arms committee members are authorized to monitor available place settings for late arriving attendees and to consider place settings without a lunch ticket as open. Finally, attendees not staying for lunch should not be seated at a table during the business portion of a meeting.



The previous board action limiting the posting of names at tables was rescinded. The board anticipates that the usual goodwill and cooperative attitude of club members will ensure the successful implementation of these decisions.
